

# Lydiard Park Academy

Admission Arrangements for entry for the academic year 2026-2027



Lydiard Park Academy is part of The Park Academies Trust. The Trust is the Admission Authority for the school, but delegates formal determination to the Admissions Committee (under the Scheme of Delegation).

Applications for places for **Year 7 entry starting in September 2026** should be made using Swindon Local Authority's coordinated admissions process. Further details are given below (PART A).

Applications for **Year 12 places for external applicants wishing to join the Sixth form in September 2026** should be made directly to Lydiard Park Academy following the application process detailed below (PART B).

**In year applications** (that is, applications to all year groups made <u>during</u> the school year) and **other year applications** (that is, for pupils wishing to join year groups other than Year 7 and 12 at the <u>start</u> of an academic year) should be made via the following link:

Lydiard Park Academy is focused on achieving the highest possible results with each child, regardless of ability. The Academy has a flexible curriculum offering a range of courses in each curriculum area, thereby allowing each child to follow a course commensurate with their ability in that subject. As well as offering challenging courses in each curriculum area, the Academy has special programmes for pupils who are academically gifted and/or have particular talents relating to sport. The Academy's published admission number (PAN) is set at a level that allows the Academy to maintain a favourably low average class size. Lydiard Park Academy is inclusive and complies with its duties under the Equality Act 2010 and the SEND Code of Practice.

Pupils are admitted to Lydiard Park Academy at age 11 to Year 7 without reference to ability or aptitude. Our arrangements for this are included here as PART A.

Pupils are admitted to The Park Academies Trust Sixth Form if they meet our minimum academic entry criteria. Arrangements for this are included as Part B.

#### **Definitions and Details**

#### **Parent**

Parent refers to the natural or adoptive parents of a child (irrespective of residence, contact or parental responsibility) and non-parents with care or parental responsibility.

#### Sibling

Sibling refers to a child who has a brother or sister, half brother or sister, adopted brother or sister, step brother or sister or the child of the cohabiting partner, foster brother or sister where the child for whom the Academy place is sought is living in the same family unit at the same address as the sibling who is attending Lydiard Park Academy at the time of admission (please also see Home Address section below). Checks will be made with the relevant school to ensure addresses match. Sibling does not include the children of friends or extended family members living at the same address.

#### **Looked After Child**

A Looked After Child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services function defined by Section 22 (1) of the Children Act 1989. This also applies to a 'Looked After Child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, residence or special guardianship order or children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted. If children have ever been Looked After or Adopted or subject to a residency or special guardianship order evidence would need to be provided.

#### **Children of Staff**

Staff are defined as employees being on the permanent payroll of The Park Academies Trust with Lydiard Park Academy as a place of work for at least two years prior to the date of application and/or having been recruited to fill a vacant post for which there is a demonstrable skill shortage. Children of staff includes foster children. The completion of a supplementary form is required for consideration under this oversubscription criteria (see Appendix 2).

#### **Home Address**

The home address given on the application form must be the address where the child resides for more than 50% of the week with his or her parent or carer. The Academy will not accept more than one address as the child's home address. Where necessary to determine which address to recognise, evidence may be requested to show the address to which any Child Benefit is paid and from which the child is registered with a medical GP. Any other evidence provided by parents will also be considered in reaching a decision on the home address for admissions purposes.

#### **Children of UK Armed Forces Personnel**

Children of UK Armed Forces personnel/Crown servants moving to the area do not need to live at their new address when the application is submitted if it is accompanied by a formal letter confirming their unit postal or quartering address.

## **Waiting List**

If your child has been refused a place at Lydiard Park Academy, he or she will automatically be placed on the Academy's waiting list. Names can only be removed from the list if a parent has requested that we do so or if a place has been offered. Placing a child's name on a waiting list does not affect the parent's right of appeal against an unsuccessful application. Please note that waiting lists are created according to the over-subscription criteria and no preference is given to the amount of time spent on the list. Your child could move down the list as a result, as well as up. The Academy will keep a waiting list for **each Year 7** cohort for one academic year after the date of admittance. The Academy will keep a waiting list for places in **Year 12** up to and including the last day of September 2026, as any applicant joining after this date will have missed too much of the course to be successful.

#### **Late Applications**

The closing date for applications to the LA coordinated scheme for **Year 7 entry** is the 31<sup>st</sup> October 2025. Applications may be submitted after this date but they will be considered as late applications, which means they will not be considered until all the on-time applications have

been considered. The LA will endeavour to deal with late applications before the offer date, but it may not be possible to do this in every circumstance.

The final date for on-time applications to the **Sixth Form** is the 31<sup>st</sup> August 2026. Applications may be submitted after this date but they will be considered as late applications, which means they will not be considered until all the on-time applications have been considered.

# Applications for admission outside of normal age group

On very rare occasions, you may feel it is in your child's best interests for them to be admitted to school outside of their normal age group, for example, if a child is gifted and talented or has experienced problems such as ill health. To apply for an admission outside of the normal age group for your child, you will still need to complete the relevant application form and should also complete the academy's supplementary information form (Appendix 1).

# **Appeals Procedure**

Any child who is refused a place at the Academy has the right to appeal against this decision to an independent panel. Details regarding how to appeal, including the deadline for lodging an appeal can be found on the Admissions page for the school. The Academy will arrange for an independent panel to consider the appeal, in line with the Appeals Code.

#### False information.

Any place offered on the basis of a fraudulent or intentionally misleading application, e.g. giving a false address, will be withdrawn. It is for the parents or carer to satisfy Admissions Committee of their circumstances, as they apply to the admission criteria at the time of application.

#### **Admissions Procedure**

Applications must be made through the Local Authority's Coordinated Scheme and all instructions and deadlines in the scheme should be adhered to by applicants. The deadline for applications is 31st October 2025. Offers of places will be made on 2nd March 2026 (national offer day). Late applications are dealt with in accordance to the scheme procedures. # **Published Admissions Number (PAN)**

The published admission number (PAN) of children aged 11 for the academic year commencing on 1st September 2026 will be 232.

#### Children with an Education Health and Care Plan

Children with an Education Health and Care Plan (EHCP) will always be admitted where the plan names Lydiard Park Academy as the designated school. Children admitted through the EHCP process are admitted under separate statutory arrangements managed by the relevant Local Authority and are not admitted under this policy.

# **Oversubscription Criteria**

When applications for admission exceed the number of places available in any year group the following oversubscription criteria will be applied in the order set out below, to decide which students to admit:

- 1. A 'Looked After Child' or a child who was previously looked after. Previously looked after children are those who immediately after being in care became subject to an adoption order, child arrangements order or special guardianship order including children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted.
- 2. Any child who has a sibling attending the Academy at the time of admission. Sibling refers to a child who has a brother or sister, half brother or sister, adopted brother or sister, step brother or sister or the child of the cohabiting partner, foster brother or sister. The sibling can be in any year group at the Academy.
- 3. Any child of a member of staff based at Lydiard Park Academy and employed by The Park Academies Trust for two or more years at the time at which the application for admission to the school is made, and/or who were recruited to fill a vacant post where there is a demonstrable skill shortage. This includes step children, foster children and children of cohabiting partners. The employee should complete the Supplementary Information Form (Appendix 2).
- 4. All other children not falling into any of the categories above.

#### Tie Breaker

In all cases where the Academy is oversubscribed, distance, measured as a straight line between the Local Land and Property Gazetteer point of the applicant's home address and the school, and using the Local Authority's computerised system, will be used to prioritise applications within the over-subscription criteria. If the direct distance does not separate applicants, places will be offered by random allocation.

# Twins, triplets and higher multiple births

In the case of multiple births the Admissions Committee will admit all the children.

# Part B – Admission into Year 12, September 2026

Administration for admissions to The Park Academies Trust Sixth Form is the responsibility of the Principal at Lydiard Park Academy. Any queries regarding Sixth Form admissions should be directed to the Academy at the usual contact address.

Year 11 pupils already on roll at Lydiard Park Academy (internal applicants) who decide to stay for Sixth Form level studies and meet both the general and minimum entry requirements (below) will remain on roll. In addition, there are 50 places for students from outside the Academy (external applicants). All students will need to meet both the general and minimum entry requirements below.

External applicants will be usually admitted into the Academy Sixth Form at the start of the autumn term in each academic year.

# **Minimum Entry Requirements**

Places in Year 12 will be offered on the basis of students obtaining the appropriate grades. Offers made are provisional on students attaining the entry requirements, and subject to availability of places in the appropriate pathway, courses and classes.

Each pathway has a 'points based' entry criteria based on GCSE grades. GCSE points are calculated by totalling the numeric grade from the **EIGHT BEST GCSE** grades. Vocational qualification grades will be converted into numeric grades, e.g. a Level 2 Pass is a grade 4, Merit grade 5 and Distinction grade 6. Our pathways consist of the following options:

## **Academic Pathway**

Our minimum entry requirements start from 30 GCSE points, including five at grade 5 or above.

# **Vocational Pathway**

Our minimum entry requirements start from 25 GCSE points, including five at grade 4 / Level 2 merit or above.

Details of the minimum entry requirements for each course will be clearly published in the Sixth Form Prospectus. All those seeking admission to the Sixth Form must achieve the necessary grades for access onto the courses they have chosen.

# The application process

Application for the Sixth Form must be made via the application process which will be detailed in the 2026/27 prospectus available from 11<sup>th</sup> November 2025. Applications can be submitted online via the Sixth Form website.

A student will only be admitted to the Sixth Form of the Academy provided they meet the general admission criteria as well as the minimum entry requirements for their choice of courses.

# Offer of places

An offer of a place at Lydiard Park Academy is not a guarantee that courses selected on the application form will definitely be available.

# Oversubscription criteria

Where the number of eligible external applicants for a course of study exceeds the places available then admission will be determined in accordance with the following priority of admission criteria

- A 'Looked After Child' or a child who was previously looked after. Previously looked after children are those who immediately after being in care became subject to an adoption order, child arrangements order or special guardianship order including children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted.
- 2. Any applicant who has a sibling attending the Academy at the time of admission. Sibling refers to a child who has a brother or sister, half brother or sister, adopted brother or sister, step brother or sister or the child of a cohabiting partner, foster brother or sister. The sibling can be in any year group at the Academy, including Years 12 and 13.
- 3. Applicants who attended Year 11 at Abbey Park School, Highworth Warneford School or The Deanery CE Academy.
- 4. Any child of a member of staff based at Lydiard Park Academy and employed by The Park Academies Trust for two or more years at the time at which the application for admission to the school is made, and/or who were recruited to fill a vacant post where there is a demonstrable skill shortage. This includes step children, foster children and children of cohabiting partners. The employee should complete the Supplementary Information Form (Appendix 2).
- 5. All other applicants not falling into any of the categories above.

#### Tie Breaker

In all cases where the Academy is oversubscribed, distance, measured as a straight line between the Local Land and Property Gazetteer point of the applicant's home address and the school, and using the Local Authority's computerised system, will be used to prioritise applications within the over-subscription criteria. If the direct distance does not separate applicants, places will be offered by random allocation.

#### Twins, triplets and higher multiple births

In the case of multiple births the Admissions Committee will admit all the children.

# Changing courses after commencing study in the Sixth Form

Whilst the Academy aims to be flexible where possible, changing courses inevitably means missed learning and some disruption to teaching. Consequently, courses can only be changed if:

- \* the course change is completed within the first four weeks of the Academy year and
- \* a student is recommended to change by a department because they are unlikely to be successful on their original course choice *or*
- \* it becomes evident that a change in career aspirations necessitates a change in course, and this change is agreed in meetings with the student's parent/s or guardian.



# **Appendix 1: APPLICATION FOR ADMISSION OUTSIDE NORMAL AGE GROUP**

Please read before completing the form: This form is <u>not</u> an application for admission and needs to be completed <u>in addition</u> to the relevant application form in instances where admission is sought to a year group outside of a child's normal age group. This form should be completed and submitted to The Park Academies Trust as soon as possible, and preferably before the application for admission itself has been submitted.

Applications may be made for a number of reasons, for example where the candidate is considered to be gifted or talented and wants to be admitted to the year above, or where the candidate has experienced problems such as ill health or family issues and wants to be admitted to the year below. The candidate may have been educated outside normal age group at primary school and wants to continue her education without skipping or going back a year.

Determination of applications for admission outside normal age group is at the sole discretion of the academy's Admissions Committee, and whilst there is a statutory right to appeal against the refusal of a place at an academy for which they have applied, this right does not apply if the candidate is offered a place at the academy but it is not in their preferred age group. However, a complaint may be submitted under the academy's Complaints Policy.

The Admissions Committee will consider the circumstances of each case and make a decision in the best interests of the candidate. The Admissions Committee will take into account:

- The parents' views;
- The Principal's view;
- Information provided about the candidate's academic, social and emotional development;
- Where relevant, the candidate's medical history and the views of the candidate's medical professionals;
- Where relevant, whether the candidate has previously been educated outside of their normal age group;
- Whether the candidate would have naturally have fallen into a lower age group were it not for having been born prematurely;
- The effect of the candidate ceasing to be of compulsory school age in a year group other than Year 11.

This is a non-exhaustive list, and there may be other factors that the person completing this form feels are relevant and the Admissions Committee should consider.

Please state the candidate's official name only, and use block capitals throughout.
