

# **SAFEGUARDING AND ATTENDANCE**

Safeguarding and attendance go hand in hand in supporting your child's wellbeing and progress. A safe environment helps pupils feel confident and ready to learn, and regular attendance ensures they don't miss out on valuable learning.

## **Online Safety**

The number of incidents that we as a school receive that involve an element of online usage is increasing.

We are aware that as our pupils come from Primary Schools and start to become more independent, their online lives become increasingly complex. Social media platforms like Snapchat, Instagram, TikTok, and WhatsApp are central to teen communication, but they also present risks—from exposure to harmful content and cyberbullying to online grooming and pressure to share inappropriate material. It's essential for parents to stay informed and actively support their child's digital wellbeing.

Some online behaviours, such as sharing explicit images even between peers can constitute criminal offences under UK law. Other risks include harassment, hate speech, and exploitation through social media. Open conversations about responsible online behaviour, privacy settings, and the legal consequences of certain actions can help your child make safer choices. Encourage them to think critically about what they share, who they interact with, and how to report anything that makes them uncomfortable.
