	Implementation (Year 10)	Year Overview	Pupils begin their GCSE History in term 6 of year 9 in order to cover the knowledge content needed. They begin studying medicine in Britain c.1250-present, a topic which enables them to get a sense of chronology and cahnge and continuity. In term three they will begin their second topic of Early Elizabethan England, this has slightly more absract content such as religious differences but the questions types of broadly the same as the pervious medicine topic and therefore the skills can be built upon. In terms 5 and 6 they begin their study of Weimar and Nazi Germany, 1918-39. They continue to build skills of source analysis and evauluation but also are introduced to the way in which historical interpretations differ.
